PC/ i2A is now accepting applications to award 1 Research Scholarship (BI) within the scope of the project “CERNAS”, project, with the operation code UIDB/00681/2020, of the Polytechnic Institute of Coimbra, financed by the Science and Technology Foundation through the Program of MULTIANNUAL FINANCING OF R&D UNITS 2020-2023, as follows

1- The aim of the Research Scholarship is to follow the next Project Tasks:

- 1) Analysis of the performance of researchers and ongoing projects at CERNAS
- 2) Logistical support in the preparation of applications for national projects, international R&D projects
- 3) Support the development of knowledge transfer and information management strategies.

Generic scientific area: Agricultural Sciences and Environment

Specific scientific area: Agriculture

2-Requirements:

- Degree in the field of Agricultural Sciences;
- With experience in:
 - a) Demonstrated experience of working or volunteering/association in academic institutions of higher education
 - b) Experience in the governance of associations or other organizations preferably in the area of agriculture and natural resources.
 - c) Experience in knowledge dissemination work.

3-Work Plan:

- Support knowledge transfer efforts to the business sector within the scope of CERNAS
- Develop research work for the management and dissemination of science
- Develop work in the area of investigation of the extension of technical and scientific knowledge.
- Collaborate in the preparation of applications for projects with national and international funding.
- Ensure, together with other team members, representation and communication functions, both with national institutions and with the international community.

4-Scholarship Length:

The fellowship has a duration of 6 months, renewable for identical periods on an exclusive basis, according to the Research Grants Regulation of the Foundation for Science and Technology, I.P. into force, scheduled to start on September 5, 2021, and a maximum duration of 2 years.

5-Monthly Maintenance Allowance:

835,98 euros, according to the table of scholarship amounts awarded by FCT to positions held in Portugal (www.fct.pt/apoios/bolsas/valores). The payment will be made by bank transfer.

To this amount is added the voluntary social insurance corresponding to the first tier, and a workplace accident insurance contract.

6-Workplace:

The work will be developed mainly at Escola Agrária of the Coimbra Polytechnic , with sporadic trips out related to the project research development or results reporting, under the supervision da Professor Ph.D Maria de Fátima Martins Lorena de Oliveira.

Candidates have a period of 10 working days to express their opinion during a prior hearing of interested parties, pursuant to articles 121 et seq. of the Code of Administrative Procedure, and that the final decision may be filed within the deadline. 15 working days, or, alternatively, an appeal is filed within 30 working days, both counting from the respective notification.
